## **September Membership Meeting**

The speaker for the September Membership Meeting is Tom Blair, PE, MoDOT District Engineer - St. Louis. Tom Blair has the honor and humbling task of leading more than 700 dedicated team members in taking care of and operating the state transportation system in the St. Louis region. The district includes the City of St. Louis, St. Louis, St. Charles, Jefferson and Franklin counties, making it part of the 7<sup>th</sup> largest transportation system in the nation.

Mr. Blair will discuss the \$2.8 billion "IMPROVE I-70" project to add an additional east and west bound lane to I-70 across the state. The safety and economic prosperity of Missourians depends, in part, on an I-70 that grows along with the state and nation. That's why the Missouri Department of Transportation is working to improve I-70. Today, many portions of the facility are strained beyond capacity and have outdated interchange designs which increase delays and dampen economic activity.

Missouri's FY2024 budget from the General Assembly and supported by Governor Parson provides General Revenue for the costs to plan, design, construct, reconstruct, rehabilitate and repair three lanes in each direction on approximately 200 miles of Interstate 70, from Blue Springs to Wentzville. In addition to his legislative duties, Mackey is an attorney and former teacher.

Mackey is a 2005 graduate of Hickory County R-1 High School. He graduated from Westminster College in 2009 with a B.A. in Early Childhood Education before getting his juris doctorate from Suffolk University Law School in 2017.

Born in New Haven, Connecticut, and raised in the Missouri Ozarks, Mackey currently resides in St. Louis. He attends the Church of St. Michael and St. George in Clayton.

### Park Commission Grant 2023

Round 24 of the annual Municipal Park Grant program closed on Monday, August 28, 2023. There were 25 applications submitted requesting approximately \$9.1 million.

Staff is reviewing the applications and will give each a preliminary score. The Park Advisory Committee is scheduled to meet in late September to score each application and rank them from highest to lowest. The Advisory Committee will forward their recommendations to the Park Grant Commission who will again review the applications and Advisory Committee score before awarding the Round 24 grants by late October. Notification will be sent to all applicants following the Commissions meeting. For those cities that are awarded a grant, the agreements will be mailed in November.

Please take advantage of the opportunity to support our affiliates, reconnect with old friends and develop new relationships with other elected officials.


## **First Zero Energy Building**

NAVIGATE Office Center to be recognized on September 15, 2023, as the 1st Zero-Energy-Certified Building in Missouri Producing Over 35,000KWH of Renewable Energy for the local Grid.

International Living Future Institue (ILFI), who certified NAVIGATE Building Solutions' St. Louis Headquarters as the first building in Missouri to earn a Zero Energy certification, will be joined by elected officials including the Mayor of Brentwood, local USGBC representatives, project participants, and invited guests on September 15, 2023, to commemorate this important achievement in Missouri history. Known as the Navigate Office Center, the 8360sf building is located as 8419 Manchester Road in the heart of Brentwood, Missouri's Brentwood Bound district.










## **Missouri Department of Conservation**

# The Justice Department proposes new ADA website accessibility rules for State and Local Governments

The Department of Justice (DOJ) is establishing technical standards for state and local governmental entities to make their websites and mobile applications accessible for people with disabilities. They will revisit regulations under title II of the Americans with Disabilities Act (ADA). In addition, DOJ is adopting a private accessibility standard for web access, which is the Web Content Accessibility Guidelines (WCAG) 2.1 Level AA. These requirements include making websites and mobile applications understandable by screen readers or similar assistive technology so the information can be accessible by individuals who are blind or have low vision. Technical standards include adding text descriptions of images and navigational links that facilitate using a screen reader. This proposal would also require captions on all videos and audio files on their websites. This will enable people who are deaf or hard of hearing to watch real-time presentations and other content.
