League Adopts Legislative Priorities

At the October 26 meeting in St. Ann, Missouri, held at the Board of Elections office, the League membership adopted six Legislative Priorities for the 2024 session. The adopted priorities are:

- Preservation and Expansion of Municipal Revenue Sources
- Juvenile Justice Reform
- Maintaining Current Municipal Election Laws
- Video Service, Telecommunications Providers and Right-of-Way
- Land Banks
- Sunshine Law and Closed Records

Legislative Spotlight

Senator Angela Walton Mosley, a dedicated Democrat, has served the citizens of the 13th Senatorial District in the Missouri Senate since January 6, 2021. Notably, she and her husband, state representative Jermond (Jay) Mosley, make history as the first married couple to concurrently serve in the Missouri Legislature.

During her first legislative session, Senator Mosley achieved a significant milestone by jointly passing House Bill 402 with her husband, making them the first married couple to accomplish such a feat in the Missouri General Assembly. The bill prevents the publishing of identifying information of state lottery winners by the State Lottery Commission and its affiliates.

Born and raised in St. Louis, specifically Walnut Park, Senator Mosley is a product of St. Louis Public Schools, having attended Visual and Performing Arts at Shaw (elementary), Marquette (middle) and Central (high school). She pursued higher education at Grambling State University, a prestigious Historically Black University, where she earned a Bachelor of Science degree.

A family of public servants surrounds Senator Mosley, as her father, late stepmother, sister, brother-in-law and husband have all served or are currently serving in the Missouri House of Representatives.

In addition to her impactful political contributions, Senator Mosley is an active member of the esteemed Delta Sigma Theta Sorority, Inc., and a dedicated union member with CWA, the Communication Workers of America, Local 6300.

The 13th Senatorial District encompasses various cities and unincorporated areas in St. Louis County, including Bellefontaine Neighbors, Black Jack, Castlepoint, Country Club Hills, Flordell Hills, Florissant, Glasgow Village, Hathaway, Jennings, Moline Acres, Old Jamestown and Riverview.

Senator Angela Walton Mosley stands committed to her constituents, striving to effect positive change and progress in her district and beyond.

The Park Commission realizes that not all municipalities have professional public works, engineering or parks staff to coordinate construction grant applications and project oversight. This has led, at times, to incomplete or inaccurate applications and delays in completing projects on time and within budget. For this reason, Commission members have adopted a policy <u>requiring</u> any municipality that does not have professional public works, engineering or parks staff, to receive a planning grant before applying for any construction grant. Commissioners believe that this policy will help assure that quality projects can be planned for and implemented in a timely and efficient manner. Planning grants of up to \$10,000 are available to help develop master plans to guide future park developments or for construction specific project planning. The planning grant applications are available throughout the year and can be found <u>here</u>. If you are considering a project for next year, it is recommended that you start the planning process as soon as possible.

2024 Outstanding Clerk Award Nominations

NOMINATION FORMS DEADLINE: January 15, 2024

The Missouri City Clerks & Finance Officers Association is accepting nominations for the 2024 Outstanding City Clerk Award. This award recognizes a city clerk or finance officer who has demonstrated outstanding service and commitment to their municipality, community and professional organizations.

The minimum requirements for the award are:

- Held a position of city clerk or finance officer for a municipality in the State of Missouri, serving at least five years.
- Active, participating member in good standing with the Missouri City Clerks and Finance Officers Association for at least five years.
- Has attained the Missouri Registered City Clerk (MRCC) or the HMC Certified Municipal Clerk (CMC) designation.

Nominations may be submitted by a municipal official or by a MoCCFOA member. The nomination form is available at www.moccfoa.org/outstanding-clerks. You may also contact Debbie Ryan, chair, at dryan@ofallon.mo.us. The deadline for nominations is January 15, 2024.

The award will be presented at the annual McCCFOA banquet in March 2024 in Columbia, Missouri.
